
Different locations for Boeing "in Seattle"




2006-2010 CTPP

- AASHTO is already working on the next round of CTPP.
- Standard geocoding about 75% coded to small geography
- Extended workplace allocation additional 15%
- 9-10% of records only have a County and Place geocode, not fine enough for TAZ or tract

Counties with extended allocation (in WHITE)




Percent of Workers in each State living in County without extended allocation



Extended Workplace Allocation



Extended Allocation Process for 2006-2010 CTPP




BEA vs. ACS results in Baltimore City and Baltimore County




Ladders of **Opportunity Connecting people** to jobs with supportive wages. Using home and workplace location, with travel mode, time of departure, for transit service planning

- Licensing updated business list from Dunn & Bradstreet


