
Which communities in King County may be most impacted by COVID-19?

Public Health – Seattle & King County created a **data tool** to identify areas in King County where individuals may be at higher risk for severe illness from COVID-19 and/or the social and economic impacts of efforts to slow the spread of COVID-19.

Goal: Ensure health equity by focusing resources toward communities that may be more vulnerable due to health, social or economic conditions Data tool: Communities in King County that may be more impacted by the new coronavirus (COVID-19)

Poverty, Language, & Access to Health Care


This disease outbreak affects everyone in our community. However, certain groups may be more vulnerable or have increased needs due to poverty, limited English proficiency, or limited health care access.

<u>Household income < 200% of the federal poverty level (FPL)</u>: People living in poverty have imited resources for foods, supplies, and housing, etc.


 <u>Uninsured</u>: People without health insurance may delay or avoid needed care and it can be dangerous if the disease becomes serious.

 <u>No personal doctor</u>: It is recommended that people should call their primary care provider before visiting a health care facility. However, 24.1% of King County adults do not have a personal doctor and they may encounter additional barriers in seeking adequate health care.
 <u>Limited English</u>: households and individuals who do not speak English very well may encounter difficulties in seeking information, assistance, and health care.



How are we using the data to address COVID-19?

- 10,000+ views since late March
- Used by local government officials, community-based organizations, healthcare providers, students, researchers
- Program planning, advocacy, emergency preparedness planning, policymaking, grant making, grant writing, research
 - Used tool to inform distribution of PPE to vulnerable populations within King County
- ACS data around multigenerational households, internet access, labor force demographics
 - Inform isolation & quarantine planning
 - Evaluate impact of COVID-19 on unemployment, working and learning at home
